As part of our commitment to Meas County and Western Colorado, St. Mary's Regional Hospital works to improve the health of the communities we serve, especially the poor and vulnerable. Our founders, the Sisters of Charity of Leavenworth, developed innovative ways to provide healthcare in their communities more than 150 years ago. Through a comprehensive assessment of community needs and strong local collaborations, we strive to continue that work today.

#### **Ensuring Access to Care Changes Lives**

Healthcare access is a significant health need in Mesa County, with capacity and cost identified as barriers to quality mental health care. With funding support from St. Mary's Regional Hospital, the Counseling & Education Center (CEC) is addressing this need by providing professional, affordable services for adults and youth in Mesa County, the majority of whom are considered low-income

An example of this model's success is a community member named Sarah who has received consistent and timely care from a trusted provider at CEC since 2019 despite



financial, insurance, and life changes . She initially came to the CEC for treatment of traumas stemming from years of abuse. Over the past five years, she experienced bouts of homelessness, unemployment, and losing insurance coverage; however, with St. Mary's grant funding and other subsidies, her treatment continued uninterrupted.

This continuity in care has allowed Sarah significant access to health and healing. She is on track to complete a bachelor's degree and the ability to live her healthiest life possible.

#### What is Community Benefit?

**Community Benefit is** integral to the mission of Catholic and other not-forprofit hospitals. It is an extension of our 'historic mission to the communities' especially the vulnerable and disenfranchised. The **Internal Revenue Service** (IRS) has federal requirements for not-forprofit hospitals to report their investments in Community Benefit activities, which are programs or activities that provide treatment and/or promote health and healing as a response to community needs:

- Improve access to care
- Enhance the health of a community
- Advance medical or health knowledge
- Reduce the burden of health care on local, state, federal government, or other community efforts


When reporting to the IRS, Community Benefit investments are organized into the following general categories:

 Unreimbursed costs for care provided to Medicaid beneficiaries


- Charity care and financial assistance for patients who are unable to pay for care
- Cash and in-kind contributions to support identified community health needs
- Health professions education, including clinical training for nursing, pharmacy, and other health professions
- Subsidized health services, which are services provided at a loss but without which the community's access to care would suffer

- Means-tested government programs, which includes the unreimbursed care under means-tested programs like the Child Health Plan Plus (CHP+)
- Community building activities, including participating in community coalitions to advance health and physician recruitment to maintain health care access.
- Research, including studies or investigations that increase knowledge made available to the public. (Note: No Research investments were reported in 2023.)
